NOMINEE ELIGIBILITY REQUIREMENTS

- The youth must be at least 14 years old
- Must be a youth with a disability
- Demonstrates a high level of self-determination
- Demonstrates:
 - a. significant involvement in the transition process to achieve her/his transition goals (nominee who is in secondary educational experiences)
 - b. ongoing transition into adult life (nominee who is post-secondary)
- Demonstrates successful navigation of the process of transition to employment, community involvement, and a meaningful adult life
- Serves as a leader and role model for other youth
